

Exhibit C – Westside TAD Advisory Committee Structure

There are two Westside TAD advisory committees: one for the Downtown Area, east of Northside Drive, and the other for the neighborhoods west of Northside Drive, for the purpose of making recommendations to Invest Atlanta with respect to funding TAD projects in the respective areas of the WTAD.

The **Westside Neighborhood TADAC** will be comprised of the following members: one designee each from NPU-L, Vine City Neighborhood, English Avenue Neighborhood, Neighborhood Community Development Corporations (CDCs), Neighborhood Churches, Neighborhood Business, and Neighborhood Nonprofit Organizations. Each of the foregoing shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by City Council.

The **Westside Downtown TADAC** will be comprised of the following members: one designee each from NPU-M, Atlanta Downtown Improvement District, Atlanta Downtown Neighborhood Association, Castleberry Hill Neighborhood Association, the Metro Atlanta Chamber of Commerce, and an At-Large Representative, who resides, owns a business, or has a civic interest within the TAD. Each of the foregoing shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by City Council.

In addition, the following members shall serve *ex officio* on the Westside Downtown and Westside Neighborhood TADACs and be confirmed by the Atlanta City Council: a City Council representative whose district includes the Westside TAD, the Fulton County Commissioner that represents the area of the Westside TAD, and the Atlanta Board of Education member whose district encompasses the Westside TAD. Each TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit D – Perry Bolton TAD Advisory Committee

The Perry/Bolton TADAC will be comprised of the following members: one designee each from NPU-C, NPU-D, NPU-G, and NPU-J, who shall each be nominated by the respective NPU Chair for confirmation by the Atlanta City Council. An At-Large Representative, who resides, owns a business, or has a civic interest within the Perry/Bolton TAD, shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by the City Council.

In addition, the following members shall serve *ex officio* and be confirmed by the Atlanta City Council: City Council representative whose district includes the Perry/Bolton TAD, Fulton County Commissioner that represents the area of the Perry/Bolton TAD, and Atlanta Board of Education member whose district includes the Perry/Bolton TAD. The Perry/Bolton TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit E - Eastside TAD Advisory Committee Structure

The Eastside TAD Advisory Committee will be comprised of the following members: one designee each from NPU-M, NPU-N, NPU-V, and NPU-W, who shall each be nominated by the respective NPU Chair for confirmation by the Atlanta City Council. An At-Large Representative, who resides, owns a business, or has a civic interest within the TAD, shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by City Council.

In addition, the following members shall serve *ex officio* and be confirmed by the Atlanta City Council: the City Council representative whose district includes the Eastside TAD, the Fulton County Commissioner that represents the area of the Eastside TAD, and the Atlanta Board of Education member whose district includes the Eastside TAD. The Eastside TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit F – Campbellton Road TAD Advisory Committee Structure

The Campbellton Road TADAC will be comprised of the following members: one designee each from NPU-P, NPU-R, NPU-S, and NPU-X, each to be nominated by the respective NPU Chair for confirmation by the Atlanta City Council. An At-Large Representative, who resides, owns a business, or has a civic interest within the Campbellton Road TAD, shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by the Atlanta City Council.

In addition, the following members shall serve *ex officio* and be confirmed by the Atlanta City Council: a City Council representative whose district includes the Campbellton Road TAD, the Fulton County Commissioner that represents the area of the Campbellton Road TAD, the Atlanta Board of Education member whose district encompasses the Campbellton Road TAD. The Campbellton Road TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit G – Hollowell/MLK TAD Advisory Committee Structure

The Hollowell/M.L. King TADAC will be comprised of the following members: one designee each from NPU-G, NPU-H, NPU-I, NPU-J, who shall each be nominated by the respective NPU Chair for confirmation by the City Council. In addition, the NW Business Association, the M. L. King Merchants Association, and an At-Large Representative, who resides, owns a business, or has a civic interest within the Hollowell/M.L. King TAD, to be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by the Atlanta City Council.

In addition, the following members shall serve *ex officio* and be confirmed by the City Council: a City Council representative whose district includes the Hollowell/M.L. King TAD, the Fulton County Commissioner that represents the area of the Hollowell/M.L. King TAD, the Atlanta Board of Education member whose district encompasses the Hollowell/M.L. King TAD. The TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit H – Metropolitan Parkway TAD Advisory Committee Structure

The Metropolitan Parkway TADAC will be comprised of the following members: one designee each from NPU-X, NPU-Y, and NPU-Z, who shall be nominated by the respective NPU Chair for confirmation by the Atlanta City Council. The President of Atlanta Metropolitan College, or that official's designee and two (2) At-Large Representatives, who reside, own a business, or have civic interests within the Metropolitan Parkway TAD, shall be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by the Atlanta City Council.

In addition, the following members shall serve *ex officio* and be nominated by their respective governing bodies and confirmed by the City Council: a City Council representative whose district includes the Metropolitan Parkway TAD, the Fulton County Commissioner that represents the area of the Metropolitan Parkway TAD, and the Atlanta Board of Education member whose district encompasses the Metropolitan Parkway TAD. The TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).

Exhibit I – Stadium Neighborhoods TAD Advisory Committee Structure

The Stadium Neighborhoods TADAC will be comprised of the following members: one designee each from NPU-V, the Peoplestown Neighborhood Association, the Organized Neighbors of Summerhill, and the Mechanicsville Civic Association, who shall be nominated by the respective NPU Chair or organization's president/chair, for confirmation by the City Council. Two (2) At-Large Representatives, who reside, own a business, or have civic interests within the Stadium Neighborhoods TAD, to be nominated by Invest Atlanta on the recommendation of the other voting members and confirmed by the City Council.

In addition, the following members shall serve ex officio and be confirmed by the City Council: a City Council representative whose district includes the Stadium Neighborhoods TAD, the Fulton County Commissioner that represents the area of the Stadium Neighborhoods TAD, the Atlanta Board of Education member whose district encompasses the Stadium Neighborhoods TAD. The Stadium Neighborhoods TADAC shall meet no less than quarterly but may meet more often at the request of a majority of its members, or at the request of Invest Atlanta. TADAC Members shall each serve a four-year term (or until a replacement TADAC Member has been duly appointed).
